### Notification

**Sub:** Representation of candidates - Screening/ Scrutiny of forms for the post of **Information Scientist – Reg.**

**Ref:** 1. Employment Notice No.17 dated 22.09.2016.  
2. Screening Committee Recommendation Notification dated 08<sup>th</sup> February, 2017.

In response to Screening Committee Recommendation cited at 2, the University received following representations, which are considered/ disposed of as below:

- Request of Sh. Mohammad Aasim Bandy S/o Mukhtar Ahmad Bandy:**  
Sh. Mohammad Aasim Bandy vide e-mail dated 10.02.2017 has submitted his request that he had applied for the said post under Employment Notification No. 15. The committee looked into his request and found that he failed to apply under Employment Notification 17 dated 22.09.2016, wherein it was clearly mentioned that *“Candidates who have applied earlier under Employment Notification No. 15 against the above said posts are required to apply a fresh, They shall be exempted from payment of fee, provided they furnish the details of DD submitted earlier”*.  
Hence, the request of candidate to consider his candidature is rejected.
- Request of Ms. Nivedita Verma D/o Sh. Romesh Verma (Sl.No. 49):**  
Ms. Nivedita Verma vide his representation dated 14.02.2017 has submitted the copies of her work Experience Certificate. The Committee looked into his request and found that the Experience Certificate submitted by the candidate is not in the relevant field. The candidate stands declared not eligible.
- Request of Sh. Avinash Singh S/o Sh. Jagdish Singh (Sl.No. 29):**  
Sh. Avinash Singh vide his representation dated 14.02.2017 has submitted the copy of his Final Semester Marksheet. The committee accepts the document and hence the candidate stands declared eligible for the post.
- Request of Sh. Gurbakash Phonsa S/o Sh. Chatru Ram (Sl.No.38):**  
Sh. Gurbakash Phonsa vide his representation dated 13.02.2017 has submitted documents in support of the candidature. The Committee looked into his request and consider that Sh. Gurbakash Phonsa is eligible for the post.
- Request of Sh. Omar Farooq Khan:**  
Sh. Omar Farooq Khan vide e-mail dated 20.02.2017 has submitted his request that he had applied for the said post under Employment Notification No. 15. The committee looked into his request and found that he failed to apply under Employment Notification 17 dated 22.09.2016,

wherein it was clearly mentioned that **“Candidates who have applied earlier under Employment Notification No. 15 against the above said posts are required to apply a fresh, They shall be exempted from payment of fee, provided they furnish the details of DD submitted earlier”**. Hence, the request of candidate to consider his candidature is rejected.

6. **Request of Sh. Ashok Kumar S/o. Sh. Pushpinder Kumar (Sl. No. 09):**

**Sh. Ashok Kumar** vide his representation dated 14.02.2017 has stated that he had submitted all the relevant documents and experience and has requested to review his application again. The Committee looked into his request and found that the Experience Certificate submitted by the candidate is not in the relevant field. Hence, **the candidate stands declared not eligible for the post.**

7. **Request of Sh. Gaurav Bhasin S/o Sh. Sh. Shyam sunder Bhasin (Sl.No. 23s):**

**Sh. Gaurav Bhasin** vide his representations dated 11.02.2017, 21.02.2017 and 20.03.2017 has submitted documents in support of his candidature. The Committee looked into his request and found that **Sh. Gaurav Bhasin is not eligible** for the post because he has **less than 60% Marks in B.Tech. and Master of Information Technology - Advanced** awarded to him by Griffith University **does not have documentary proof of its equivalence** with M. Tech. (CS/IT) degree awarded in India. As the candidate failed to submit the relevant documentary proof within the stipulated/ specified time period, hence **the request of candidate to consider his candidature is rejected.**

Further, the candidature of below mentioned candidates is being rejected on account of their failure to submit the document/clarification as below:
