Sub: Screening/ Scrutiny of forms for the post of **Senior Technical Assistant (Lab)** - Representation of candidates – Reg.

Ref: 1. Employment Notice No. 17 dated 22.09.2016
2. Screening Committee Recommendation Notification dated 22nd February, 2017

In response to Screening Committee Recommendation cited under reference, the University received following representations. The Screening/ Scrutiny Committee relooked into the representations and recommended the following:

- Request of Sh. Naiem Ahmad Wani S/o Sh. Gh Ahmad Wani (Sl.No.12):**
Sh. Naiem Ahmad vide e-mail dated 23.02.2017 claimed that he has applied for the post for the Senior Technical Assistant, Laboratory (STA) under employment Notification No.17 but his name was not in the list. However vide his e-mail dated 25.02.2017, he informed that he has found his name in the list. The candidate **stands declared eligible** as per Notification cited at 2.
- Request of Sh.Navdeep Singh S/o Sh. Charanjeet Singh:**
Sh. Navdeep Singh S/o Sh. Charanjeet Singh vide his representation dated 27.02.2017 has submitted that he applied for the post for the Senior Technical Assistant (Laboratory) under employment Notification No. 15. However, he failed to apply under Employment Notification No. 17 dated 22.09.2016. Accordingly, his request cannot not be considered and the candidate is considered as **not eligible for the post**.
- Request of Sh. Rahul Prakash:**
Sh. Rahul Prakash vide his representation dated 26.02.2017 (e-mail) has submitted that his name is not mentioned in the list of candidates. SH. Rahul Prakash applied for the post for the Senior Technical Assistant (Laboratory) under employment Notification No. 15 but failed to apply under Employment Notification No. 17 dated 22.09.2016. Accordingly, his request cannot not be considered and the candidate is considered as **not eligible for the post**.

4. **Request of Sh. Sumer Sharma S/o Sh. Navdeep Kumar Sharma (Sl.No. 55) and Request of Sh. Mohit Kumar S/o Sh. Ashok Kumar (Sl.No. 68):**

Father name of Sh. Sumer Sharma has been rectified as Sh. Navdeep Kumar Sharma instead of wrongly written as Sh. Kumar Sharma. The candidate **stands declared eligible** as per Notification cited at 2.


Father name of Sh. Mohit Kumar rectified as Sh. Ashok Kumar instead of wrongly written as Sh. Asahok Kumar. The candidate **stands declared eligible** as per Notification cited at 2.

5. **Request of Sh. Deepak Anand S/o Sh. Kewal Krishan Anand(Sl.No.76):**

The candidate vide his representation dated 01.03.2017 while giving reference to allied subject of Instrumentation engineering as per AICTE submitted that he has done B.E. (Electronics and Communication) which may be considered by the University. However, the Committee observed that the University in its Notification has asked for B.Tech./B.E. in Instrumentation and no reference for allied subjects. Hence, the request of the candidate cannot be considered and the candidate is not eligible for the post of Senior Technical Assistant.

6. **Request of Sh.Navdeep Singh S/o Sh. Charanjeet Singh:**

Same representation as at Sl. No. 2, the candidate is **not eligible for the post.**
