Age: Preferably below 35 years

Essential:


- i. Bachelor's Degree from a recognized University/ Institute
- ii. At least two years experience as LDC or equivalent in the grade of Rs. 5200-20200 + G.P. 1900 of any Central/State Govt./ University/Public Sector Undertakings and other Central or State Autonomous Bodies or holding equivalent position in the reputed private institution /corporate /bank with annual turnover of Rs. 200 crores.
- iii. Working knowledge of Computer Application.

- Note:**
1. Candidates belonging to SC/ST/OBC/PWD categories are required to submit the Caste category certificates as per Govt. of India formats at the time of interview, failing which their candidature may be rejected.
 2. In service candidates who have not forwarded their applications through proper channel are required to submit NOC at the time of interview failing which he/she shall not be interviewed.
 3. Candidates who have submitted advance copy of application form must ensure that their original application form duly endorsed must reach the office at least 10 days before the date of interview.
