- Ph.D. Supervision and award proof is required.
- Need to produce the evidence regarding the approval as PhD supervisor by BMU-Rohtak, when she was serving in SSJGC-Sirsa.
- Registration letters of Ph.D. scholars who have submitted and awarded the Ph.D. degree under her supervision.
- Need clarity on how it was possible that she joined the BMU-Rohtak in Sep 2015 and Ph.D. under her supervision was submitted in Nov 2015.
