At the outset, the Vice Chancellor extended very warm welcome to the members for attending the meeting of the Academic Council. Expressing his gratitude, the Vice Chancellor remarked that quorum had never been a problem in view of the active and strong support of worthy members. The University has been immensely benefitted by their rich experience and advice rendered in strengthening the academic functioning. Sh. Jit Singh, who joined as the first Registrar of the University on 6th September, 2013, and Prof. Shyam Singh, Academic Coordinator of the University, were formally introduced to the members.

Prof. R.N.K. Bamezai thanked the Vice Chancellor for bringing all the members together for the meeting of the Academic Council to discuss important academic issues.

The Vice Chancellor dwelt upon in detail the various initiatives taken by the University since June, 2013, such as, shifting of teaching Departments from the Temporary Academic Block I at Maha Maya crossing to the Temporary Academic Block II at Sainik Colony by adding one floor to the existing building to accommodate teaching departments, library, auditorium, committee room, common rooms for boys and girls, and Computer labs, etc., regarding, recruitment of faculty; the faculty already joined the University; the schedule of Selection Committee meetings for unfilled teaching posts; advertisement for filling up non-teaching positions; admission of students to Post-Graduate Programmes and M.Phil-Ph.D Programmes for 2013-14; conduct of examinations and declaration of results; academic activities and functions held by the University; status of possession of the land and development activities at Village Bagla; Bhomi Poojan for taking up construction work and support from University Grants Commission.

The members expressed their happiness and placed on record their appreciations on passing out of the first batch of the students and having first Alumni of the Central University of Jammu. Members suggested to maintain the data bank of the Alumni from the first batch itself for close co-ordination with them in future.

Thereafter agenda items were taken up for discussion.
