Introductory

- 4. The Vice Chancellor welcomed all the worthy members and special invitees of the Academic Council and expressed sincere thanks to the external members for sparing their valuable time for attending the meeting. The Vice Chancellor was delighted to inform the members about the appointment of Sh. Gopalaswamy Parthasarathy, Former Ambassador, as the 2nd Chancellor of the University, w.e.f. 4th July, 2018. The Vice Chancellor informed the members that Sh. G. Parthasarathy is among the 04 Ambassadors who had visited the university earlier for lectures in Central University of Jammu in the Department of National Security Studies, Department of Public Policy and Public Administration and other Departments under "Distinguished Lecture Series" funded by the Ministry of External Affairs, Govt. of India. The Vice Chancellor also informed the members that Sh. G. Parthasarathy will be making his maiden visit to the university from 6th 8th September, 2018, to preside over the University Court 5th Meeting on 7th September, 2018 and will also interact with the students/scholars, faculty and staff of the University.
- 5. The Vice Chancellor also expressed gratitude to Sh. N.N. Vohra, Former Governor of Jammu & Kashmir state and 1st Chancellor of the Central University of Jammu for guiding and supporting the University in higher learning and research endeavours.
- Thereafter, the Vice Chancellor briefed the members about the recent developmental activities and initiatives undertaken by the university during the period. He informed the members that 45 programmes under Social Sciences, Humanities, Management, Sciences, Vocational, Basic & Applied Sciences, have been running. The Vice Chancellor was pleased to inform the members that UGC has sanctioned new courses under National Skill Qualification Framework i.e. 01 in Banking and Financial Services, 04 in Make-up, Tourism, Retail and Fashion Designing cum Tailoring under Community College. Prof. Mohammad Miyan enquired about the vocational programs offered by the university and newly sanctioned courses. The Vice Chancellor informed that all vocational courses are having multiple entry and exits and are being offered in collaboration with industry partnership. He further informed that University has submitted a proposal for starting vocational courses under Deen Dayal Upadhyay Kaushal Kendras Centre. Prof. Mohammad Miyan enquired about the faculty position in these vocational courses. The Vice Chancellor informed that the University has hired contractual faculty in two vocational programmes at present i.e. B.Voc. (Retail Mgmt.) and B.Voc. (Tourism Mgmt.).
- 7. The Vice Chancellor apprised the members that this year also Central Universities Common Entrance Test (CUCET) 2018 has been successfully conducted on 6th & 7th May, 2018 at 09 centres at different locations i.e. Jammu (04 centres),

Udhampur (02 centres), Kathua (01 centres), Rajouri (01 centre) and Bhadarwah (01 new centre). The Vice Chancellor informed the members that this year approximately 38,000 applications have been received from Pan India candidates. The admissions for PG and UG courses have been completed.

- 8. The Vice Chancellor informed the members that 1st Convocation of the University has been successfully conducted on 18th March, 2018 at Zoravar Singh, Auditorium, University of Jammu. His Holiness the 14th Dalai Lama was the Chief Guest on the occasion. Prof. Amitabh Mattoo was the Guest of Honour. Degrees of Honoris Causa were conferred upon Dr. Jitendra Singh, MoS PMO, and General N.C. Vij, Former Chief of the Army Staff. The students from 2011 to 2017 batches were awarded 14 Ph.D., 20 M.Phil. and 885 Post Graduate Degrees.
- 9. The Vice Chancellor apprised the members about the average pass percentage of 2nd, 4th and 6th Semesters of Post Graduate programs and 2nd & 4th Semesters of UG programs whose exams were held in May 2018. Prof. Mohammad Miyan suggested that the pass percentage should be made available after completion of batch of particular course/program.
- 10. The Vice Chancellor apprised the members that The Jammu & Kashmir Bank has provided financial support for RFID enabled technology for library of the University as a part of MoU signed between Central University of Jammu and The Jammu & Kashmir Bank. He also informed that CUJ has signed multiple MoUs with J&K Bank for providing digitalisation, automation, and other services. The Vice Chancellor also informed that he had laid the foundation stone of J&K Bank in the campus for opening a Bank with digital infotainment facilities for students and staff of the university. He informed that J&K Bank has provided an Ambulance to the University under CSR initiatives; besides, sponsoring 02 Gold Medals (1 Male & 1 Female) for toppers of the university, Smart Cards, Research Chair, Funding for Annual Business Festivals, etc.
- 11. The Vice Chancellor apprised the members that promotion under CAS for Assistant Professor from Stage –I have been held in the University recently and presented the details of faculty benefitted under CAS.
- 12. The Vice Chancellor informed the members that university had advertised faculty positions in various programs but as per the guidelines of the UGC, the University cancelled the advertisement till the fresh guidelines in the matter are received from the UGC. He also informed that skill tests of various Non-Teaching positions were held in the month of July, 2018 and the final merit lists are being prepared for Group B and Group C posts while interview of Group A posts will be held on 29th & 30th August, 2018. Prof. Mohammad Miyan suggested that no fee should be collected from the candidates, who had already applied in the previous advertisement, but they have to

submit fresh application form along with the requisite documents, as and when the fresh advertisement will be published.

- 13. The Vice Chancellor presented the details of the meetings of the Executive Council, Academic Council, Court, Finance Committee, School Boards and Board of Studies held during the last one year.
- 14. The Vice Chancellor apprised the members that the university has signed International MoU with Deakin University, Australia. The Vice Chancellor informed that on the directions of the MHRD, the Central University of Jammu had signed MoU with Deakin University, Australia, in the presence of Sh. Prakash Javedkar, Hon'ble Minister of Human Resource Development, Govt. of India. Prof. Lokesh Kumar Verma, Academic Coordinator, Central University of Jammu, who was at Sydney at that time, signed the MoU on behalf of the University.
- The Vice Chancellor informed that recently Ball University, USA has collaborated with Central University of Jammu for Leadership through Sports programme for J&K State under 'US Mission India Public Diplomacy Grants'.
