Pharmacist (PB Rs. 5200-20200+ GP Rs. 2800)

Age: Preferably below 32 years

Essentials:

- i. 10+2 or equivalent in Science subjects from a recognized Board or University
- ii. Diploma in Pharmacy from an Institute recognized by the Pharmacy Council of India

Bachelor's degree in Pharmacy from a University/ Institute approved by the Pharmacy Council of India.

- iii. Registered as Pharmacist under the Pharmacy Act, 1948.
 - **Note:** 1. Candidates belonging to SC/ST/OBC/PWD categories are required to submit the Caste category certificates as per Govt. of India formats at the time of interview, failing which their candidature may be rejected.
 - 2. In service candidates who have not forwarded their applications through proper channel are required to submit NOC at the time of interview failing which he/she shall not be interviewed.
 - 3. Candidates who have submitted advance copy of application form must ensure that their original application form duly endorsed must reach the office at least 10 days before the date of interview.

- 1. Candidates who are found conditionally eligible are called upon to submit their documents/ clarification within seven (07) days from the **date of uploading of recommendation (08.02.2017)** on the University website failing which their candidature will be rejected without any further queries/representations.
- 2. All the genuine queries/observations of applicants will be entertained within a period of seven (07) days, from the **date of uploading of recommendation (08.02.2017)** on the University website.
