Two experts to be nominated by the Chairperson in case there is a need for their inputs for specialized area(s) in that event one external expert shall be from Industry/ Practitioner, whichever applicable.	1. 2. The term of office of members other than a and b shall be three years.

3. The Board of Studies shall ordinarily meet at least twice a year and on such occasions as may be determined by the Vice-Chancellor.

4. The quorum for the Board of Studies meeting shall be 50% of the members which shall include at least one outside expert.
