The Term of office of members other than that a, b and c shall be three years.

The Board of Research Studies under the overall guidance and supervision of the Academic Council shall perform following functions.

1. Determine the priority areas of research to be undertaken in various departments/centers in consonance with the role and responsibility of the University and also create facilities where ever necessary for core thrust areas of research in each department.
2. Consider and recommend research proposals for funding by the UGC, DST, ICSSR or other National and International agencies.
3. Shall inquisitively examine and review the status and progress of research in each department from time to time.
4. Evolve norms for consultancy services to be provided by departments and also determine mechanism of sharing of revenue earned between the investigator (s) (Principals and Co-investigators) and the University, as and when needed; and
5. Shall also perform such other functions as may be assigned to it by the Academic Council, from time to time.



Meeting: The Board of Research Studies shall ordinarily meet at least twice a year and may determine its own procedures for transacting its business. The meeting of t he Board shall be convened by the Chairperson. In his absence, Pro-Vice Chancellor shall preside over the meeting.

The quorum for the Board of Research Studies meeting shall be one third of the total members.
