This is with reference to letters/representations received from the following persons wherein they have requested for considering their candidature for the post of Cook.

In this regard, the Committee has observed as under:

**1. Request of Sh. Mohinder Singh S/o Sh. Sena Ram (Form No. 54)**

In case of Sh. Mohinder Singh, the Committee has observed that as against the “no relevant experience” remark the candidate has now submitted revised proper/relevant experience certificate which is considered for the post of Cook. Therefore, Sh. Mohinder Singh is **eligible** for the post of Cook.

**2. Request of Sh. Sanjay Kumar S/o Sh. Hukam Chand (Form No. 55)**

In case of Sh. Sanjay Kumar the Committee has observed that as against the “no relevant experience” remark the candidate has requested that he has already submitted the required experience certificate. The Committee has reconsidered the case on merit basis and considered him eligible. Therefore, Sh. Sanjay Kumar is **eligible** for the post of Cook.

**3. Request of Sh. Charan Singh S/o Sh. Des Raj (Form No. 59)**

In case of Sh. Charan Singh, the Committee observed that the candidate has produced another experience certificates from other organization and the dates are overlapping in present and previous experience certificate. Hence the contradiction negates the claim. Therefore, Sh. Charan Singh is **not eligible** for the post of Cook.

**4. Request of Sh. Ram Krishan Singh S/o Sh. Roshan Lal (Form No. 94)**

In case of Sh. Ram Krishan Singh, the Committee observed that as against the earlier no proper/relevant experience certificate submitted by the candidate, the candidate has now submitted the proper relevant experience which is considered for the post of Cook. Therefore Sh. Ram Krishan Singh is **eligible** for the post of Cook.

**5. Request of Sh. Sanjay Singh S/o Sh. Rattan Singh (Form No. 106)**

In case of Sh. Sanjay Singh, the Committee observed that the candidate has produced another experience certificates from other organization and the dates are overlapping in present and previous submitted experience certificate. Hence the contradiction negates the claim. Therefore, Sh. Sanjay Singh is **not eligible** for the post of Cook.

**6. Request of Sh. Rinku Sharma S/o Sh. Gopal Krishan (Form No. 147)**

In case of Sh. Charan Singh, the Committee observed that the candidate has produced another experience certificates from other organization and the dates are overlapping in present and previous submitted experience certificate. Hence the contradiction negates the claim. Therefore, Sh. Rinku Sharma is **not eligible** for the post of Cook.
