The University invites Online applications from eligible Indian Nationals for the following posts under Dr. Ambedkar Chair sanctioned by Dr. Ambedkar Foundation (DAF), Ministry of Social Justice & Empowerment, Govt. of India, New Delhi on deputation/contract basis:

Note:

- (a) **Superannuated Person will not be eligible for the post of Chair Professor.**
- (b) **Above posts are tenure posts and subject to the approval by DAF, Ministry of Social Justice & Empowerment, Govt. of India, New Delhi.**
- 1) For the post of Chair Professor, the University will follow the "**UGC Regulations on Minimum Qualifications for the Appointment of Teachers and Other Academic Staff in University and Measures for the Maintenance of Standards in Higher Education 2018**" and Notifications, Notice and Circulars issued by the UGC in this regard from time to time.
 - 2) Dr. Ambedkar Chair sanctioned by Dr. Ambedkar Foundation, Ministry of Social Justice and Empowerment, Govt. of India, New Delhi on deputation/contract basis will be initially for one year, which may be extended.

MINIMUM QUALIFICATION:

1. For the post of Chair Professor :

(A) (i) An eminent scholar with Ph.D. qualification(s) in any relevant subject with the specialization in Dr. Ambedkar's Thought & Philosophy/Education, Social justice/Inclusion/Harmony and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in the Appendix II, Table 2.(UGC Regulation, 2018)

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor and/or research experience at equivalent level at the University/National Level Institution with evidence of having successfully guided doctoral candidate.

OR

An outstanding professional, having Ph.D. Degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above)/ industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

GENERAL CONDITION & ESSENTIAL INFORMATION

1. Applications incomplete in any respect and not accompanied with relevant certificates/documents/photographs/copies or orders etc., as desired or without requisite fee will be summarily rejected.
2. Candidates are advised to satisfy themselves before applying that they possess essential qualifications laid down in the advertisement.
3. Candidates already in employment would be required to submit their application through proper channel, and submit 'No Objection Certificate', Experience Certificate from the Employer failing which they may not be considered. However, they may produce Original 'No Objection Certificate' etc. at the time of interview.
4. Mere eligibility will not entitle any candidate for being called for interview. Applicants having higher qualification and merit will be given preference.
5. The candidates will be called for interview, wherever applicable, by the University on the recommendations of Screening/Scrutiny Committee.
6. Experience and qualification will be reckoned as on the last date of submission of online application.
7. The service conditions including AGP and GP shall be as per UGC/University Rules/Norms.
8. The University shall verify the antecedents or documents submitted by the candidate within three month of the joining. In case, it is detected at any time that the documents submitted by the candidates are fake or the candidate has clandestine antecedents / background and has suppressed or altered the said information, then his/her services shall be terminated immediately and appropriate action shall be initiated as deemed fit.
9. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel any communication made to the candidate.

10. SC/ST and PWDs Candidates must submit/upload Caste Certificate/Medical Certificate in GOI prescribed format duly issued by the Competent Authority.
11. OBC (Non-creamy layer) Candidates are required to upload/submit a certificate in a prescribed format duly issued on or after 01/07/2016 by the competent authority. To avoid delay in submission of applications, OBC candidates are allowed to apply with their OBC certificate issued before 01/07/2016. Such candidates shall be required to produce the updated OBC Certificate at the time of interview.
12. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
13. Candidates must upload self-attested copies of certificates and mark-sheets from matriculation (10th Standard) onwards in support of their qualifications and reprints of publications and certificates in support of their claim for the post along with the application form.
14. Canvassing in any form will be a disqualification.
15. No interim correspondence shall be entertained.
16. In case of any dispute, suite or legal proceedings against the University, the jurisdiction shall be restricted to the Hon'ble Courts of Jammu and Kashmir.
17. The service contract may be terminated at any time with one month's prior notice by the university or one month salary may be paid in absence of notice without assigning any reason. The candidate is also required to give one month's advance notice or else deposit one month's salary; in case the candidate is leaving during the contract period.
18. After joining the position under Dr. Ambedkar Chair, the candidate will have to abide by the Rules, Regulations and Ordinances of the University/Rules of UGC/Rules of Govt of India applicable from time to time. S/he may be assigned any duty within/outside the University depending upon the exigencies of the work.
19. The appointment is purely on deputation/ contractual basis. It will not give any right for permanent employment.
20. The selection procedure for Chair Professor shall be as laid down by the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic staff in Universities and Colleges and Measures for maintenance of Standards in Higher Education, 2018 and as amended from time to time.
21. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree holders, who have obtained their Master's Degree prior to 19th September, 1991.
22. Candidates awarded degree by Foreign Universities are required to submit Equivalence Certificate issued by Association of India University, New Delhi.
23. Only online applications will be accepted, which can be filled at University website www.cujammu.ac.in and self attested testimonial, certificates, Educational

qualifications and all supporting documents should also be uploaded along with application.
