# **Guidelines for Admission under Self-Finance Seats** (UG/Integrated Admissions: 2025-26)

#### 1. Merit Criteria for Admission:

Admission to self-finance seats in various programmes will be strictly based on merit as per the following order of preference:

Date: 26-08-2025

- (a) **First preference:** Students who appeared in CUET(UG)-2025 conducted by NTA, registered with Central University of Jammu, but could not secure admission under open merit.
- (b) **Second preference:** Students who appeared in CUET(UG)-2025 conducted by NTA but are not registered with Central University of Jammu.
- (c) **Third preference:** Students who did not appear in CUET(UG)-2025 and are not registered with Central University of Jammu. Their merit will be prepared on the basis of marks obtained in 10+2 examination.

#### 2. Seat Allocation:

- o The number of self-finance seats will be 25% of the total intake in the respective programme.
- o Allocation of seats will be made strictly on the basis of the merit list prepared under the above criteria.

## 3. Fee Payment:

- o The self-finance fee must be paid in one lump sum, at the time of admission.
- In addition to the self-finance fee, the **regular tuition and other fees** shall be paid as per the notified fee structure of the University.
- o Failure to deposit the self-finance fee within the stipulated time will result in cancellation of the admission offer.

# 4. Eligibility Conditions:

- o All applicants must fulfill the **minimum eligibility criteria** prescribed for admission to the respective programme as per University norms.
- Students admitted under self-finance seats will be subject to the same academic rules, regulations, and requirements as those admitted under open merit.

### 5. Non-Transferability of Seats:

Self-finance seats are **non-transferable**. Once allotted, the seat cannot be transferred to another programme or candidate.

### 6. Reservation Policy:

 The reservation policy of the Government of India/University will not apply to self-finance seats. Admissions will be made purely on merit within the given preference categories.

#### 7. Withdrawal and Refund Policy:

o If a candidate withdraws admission after payment of fees, the **refund policy notified by the University** shall apply. The self-finance component of the fee is **non-refundable** 

# 8. Equal Academic Status:

o Students admitted under self-finance category shall enjoy **equal academic rights, facilities, and obligations** as those admitted under open merit. No distinction will be made in teaching, evaluation, or award of degrees.

# 9. Dispute Redressal:

• In case of any dispute regarding admission under self-finance seats, the decision of the **Hon'ble Vice Chancellor/Admission Committee of the University** shall be final and binding.
