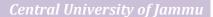

For conferring Honoris Causa Degree to distinguished personalities, the Vice Chancellor may suggest names in the next Executive Council meeting before holding Convocation. It was also resolved that the Executive Council meeting shall be convened before holding Convocation in the first quarter of the year 2020."

The University is scheduled to conduct its 2nd Convocation in the month of March 2020. In principal agreement was conveyed by the Rashtrapati Bhawan that the Hon'ble Visitor of the University His Excellency Sh. Ram Nath Kovind ji, Hon'ble President of India will preside over the Convocation with his gracious presence. However, no date and time has been yet confirmed from the Rashtrapati Bhawan till date.

The Executive Council may consider names of distinguished personalities for conferring Honoris Causa Degree(s) in the second convocation of the University.

The matter is placed before Executive Council for consideration.



To recommend three nominees of the Executive Council as members of Search Committee for the post of Vice Chancellor, Central University of Jammu

The Central Universities Act, 2009, under the Statutes of the University clause 2, sub-clause (I) & (II) provides that;

- 2 (I) The Vice-Chancellor shall be appointed by the Visitor from out of a panel recommended by a Committee as constituted under clause (2):

 Provided that if the Visitor does not approve any of the persons included in the panel, he may call for an extended fresh panel.
- 2 (II) The Committee referred to in clause (I) shall consist of Five persons, out of whom three shall be nominated by the Executive Council and two by the Visitor, and one of the nominees of the Visitor shall be convener of the Committee.

 Provided that none of the members of the Committee shall be an employee of the University or a College or an Institution maintained by the University or a member of any authority of the University".

The MHRD, Department of Higher Education vide letter F. No 52-4/2019-CU.III dated 5th November, 2019 has requested Central University of Jammu to convene the meeting of the Executive Council of the University and provide three nominees of the Executive Council to be the members of the Committee for making selection to the post of Vice-Chancellor, CUJ. The copy of the letter along with MHRD guideline dated 12.03.2015 are place at **Annexure – II**

The Executive Council in its 15th meeting held on 10.12.2019 vide resolution no. 33 resolved as follows:

"In view of lack of quorum, the panel of nominees as prepared and sealed in the envelope in the 15th meeting of the Executive Council chaired by the external EC member be again placed in the next EC meeting to be convened shortly."

All members desirous to apply for the post will be requested to recluse themselves from this agenda point.

The matter is placed before the Executive Council for nomination of three nominees of the Executive Council for Search Committee for the post of Vice Chancellor, Central University of Jammu.
