To confirm the admission of Ms. Muskan Gupta in the Department of English – Transfer of Credits

Ms. Muskan Gupta R/o District Jammu was pursuing M.A. English from Sri Venkateswara College, University of Delhi. After appearing in Ist semester examination, her father passed away and she approached Central University of Jammu for admission in 2nd semester of M.A in English.

Credit Equivalence Committee of School of Languages as per Ordinance No. 49, Clause 5, recommended her admission on following grounds:-

1. She had qualified Central University of Jammu entrance exam (CUCET 2019) and scored 4th Rank in the merit list.
2. Total credits earned in semester – I were same in University of Delhi and Central University of Jammu. i.e. 20 credits

Recommendations of Credit Equivalence Committee is placed as **Annexure – XVII**

Deans Committee on 4th Feb, 2020 recommended her admission to 2nd semester of M.A English in CUJ subject to:

1. Submission of Migration / No Objection Certificate from University of Delhi
2. A certificate from the Principal of the College / Head of the Institution last attended by her, testifying the record of attendance and conduct of the student
3. Payment of Admission Fee as prescribed by Central University of Jammu

Dean, School of Languages and Head, Department of English on 24th Feb, 2020 intimated that one UR seat is vacant in the department of English & Ms. Muskan Gupta subject to fulfillment of conditions laid down by Dean's Committee may be admitted.

The University on 11th feb, 2020 issued NOC in favour of Ms. Muskan Gupta as a special case and one time exception for admission in 2nd semester of M.A English in department of English subject to following conditions of Ordinance No. 42:

1. Submission of Migration / No Objection Certificate from University of Delhi
2. A certificate from the Principal of the College / Head of the Institution last attended by her, testifying the record of attendance and conduct of the student
3. Payment of Admission Fee as prescribed by Central University of Jammu

Principal, Sri Venkateswara College, University of Delhi vide letter No. SVC/Admn/2020/AK dated 17.02.2020 issued Transfer Certificate citing no objection in favour of Ms. Muskan Gupta being transferred to Central University of Jammu. Further, University of Delhi intimated vide letter No. Exam.III(i)R/2019/1 dated 17.02.2020 that result of Ms. Muskan Gupta is being complied. Accordingly Ms. Muskan Gupta submitted



an affidavit stating that she will not claim admission in 2nd semester if she fails 1st semester examinations.

On 17th March, 2020 the University accorded provisional admission to Ms. Muskan Gupta on the recommendations of the Deans Committee and Admission Committee of the Department of English on compassionate grounds and one time exception. On 26th May, 2020 her first semester result was declared by University of Delhi in which she passed all the subjects.

Action taken by the Vice Chancellor in granting admission to Ms. Muskan Gupta for pursuing M.A in English (w.e.f. 2nd semester) may be ratified by the Academic Council.

To start Post Graduate programme in Biotechnology

Department of Biotechnology (DBT), Ministry of Science and Technology, Government of India invited proposal for starting PG Degree Programme in Biotechnology last date of which was 20.01.2020. In response to the said advertisement of DBT, Centre for Molecular Biology (CMB), Central University of Jammu prepared a proposal for starting PG Degree in Biotechnology (M. Sc. Biotechnology) and submitted the same to DBT.

This proposal was ratified by 3rd meeting of Board of Studies of CMB held on 14.02.2020. Minutes of Board of Studies are placed at **Annexure - XVIII**.

DBT vide letter dated 14.05.2020 approved the proposal of CUJ & conveyed its acceptance for starting M.Sc Biotechnology subject to DBT terms and conditions for the said programme. Copy of DBT's letter is placed at **Annexure - XIX**

ACADEMIC COUNCIL-13 / Item No. 07

To change the nomenclature of Ph.D. degree in Life Sciences with specialization in Molecular Biology to Ph.D. in Biotechnology

Centre for Molecular Biology (CMB) in its 3rd meeting of Board of Studies held on 14.02.2020 has recommended change in nomenclature of existing **Ph.D. degree in Life Sciences with specialization in Molecular Biology** to **Ph.D. in Biotechnology** citing following reasons:-

1. Vagueness in nomenclature of the existing degree
2. Non-suitability with respect to job prospects in Public Sector / Industry
3. Ineligibility for the post of Assistant Professor / Scientist on the ground that the nomenclature of the degree does not fit in eligibility criteria of recruiting agencies.

The Board of Studies also recommended that the change in nomenclature be made effective from Academic Session 2019-20 so that students enrolled for Ph.D. programme w.e.f. Academic Session 2019-20 may be benefitted from this change in nomenclature.

Minutes of Board of Studies approved by Dean of the School recommending change in nomenclature are placed at **Annexure - XX**.

To consider starting of Ph.D. Programme in Earth Sciences in the University

1. To start Ph.D. programme in Earth Sciences with effect from Academic Session 2020-21.
2. To consider syllabuses of M.Sc. and Ph.D. programme in Environmental Sciences and Ph.D. programme in Earth Sciences.

1. Besides one-time non-refundable payment of self-financing seats as mentioned above, the Fee structure of the Program of Study as applicable to other candidates and notified by the University from time to time shall be applicable to candidates availing self-financing seats.



2. Self-financing seats will be allotted on the basis of Academic Merit of the candidate drawn after Admission Entrance Test.
3. Total number of self-financing seats will not exceed 15% of sanctioned intake capacity of each department except supernumerary seats.

(AC-10 / Item No 25) in its 10th meeting held on 31.08.2018 and vide resolution no. (AC-11 / Item No 15) in its 11th meeting held on 25.05.2019 approved the said ordinance along with exit option to students after B.Sc (Hons.). However, certain operational difficulties were encountered by the University while facilitating lateral entry of candidates at M.Sc level. Accordingly, the matter was referred to Committee consisting of following to revisit the said ordinance:

1. Dean, School of Basic & Applied Sciences
2. Dean, School of Life Sciences
3. Head, Department of Botany
4. Head, Department of Zoology
5. Head, Department of Physics & Astronomical Sciences
6. Head, Department of Chemistry & Chemical Sciences

The Committee has suggested certain modifications which have been incorporated in the said Ordinance. Recommendations of Committee will be placed at table during the meeting for perusal of Academic Council.

The matter is placed before Academic Council for consideration and its recommendation to Executive Council.
