





This is with reference to e-mail dated 29.09.2015 and letter dated 31.10.2015 received from Sh. Rajesh Talwar wherein he has requested for considering his candidature for the post of Finance Officer.

In this regard, the Committee has observed that the as per above mentioned advertisement, the requirement for the post of Finance Officer inter alia requires  
“15 years of Administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.”

In the instant case of Sh. Rajesh Talwar, from the perusal of form submitted and e-mail it has been observed that Sh. Rajesh Kumar is falling short of required experience of 8 years as Deputy Registrar or an equivalent post. He has served in the required scale (or higher scale) w.e.f 06.08.2009 to till date (15.07.2015: last date of submission of form) thereby making a total experience of 5 years 11 months as Deputy Registrar or an equivalent post which is short of required 8 years of experience.

In view of the above, it is considered that Sh. Rajesh Talwar is not eligible for the post of Finance Officer.


This is with reference to e-mail dated 30.09.2015 received from Sh. Santosh Kumar wherein he has requested for considering his candidature for the post of Finance Officer.


In this regard, the Committee has observed that ~~the~~ as per above mentioned advertisement, the requirement for the post of Finance Officer inter alia requires

“15 years of Administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.”

In the instant case of Sh. Santosh Kumar, from the perusal of form submitted and e-mail it has been observed that Sh. Santosh Kumar is falling short of required experience of 8 years as Deputy Registrar or an equivalent post. He has served in the required scale (or higher scale) w.e.f 15.09.2007 to 31.07.2012 (approx. 4 years 10 months), w.e.f. 01.08.2012 to 04.05.2013 (approx. 9 months) and w.e.f 05.05.2014 to till date (15.07.2015: last date of submission of form) (approx. 1 year 2 months) thereby making a total experience of 6 years 9 months as Deputy Registrar or an equivalent post which is short of required 8 years of experience.

In view of the above, it is considered that Sh. Santosh Kumar is not eligible for the post of Finance Officer.
